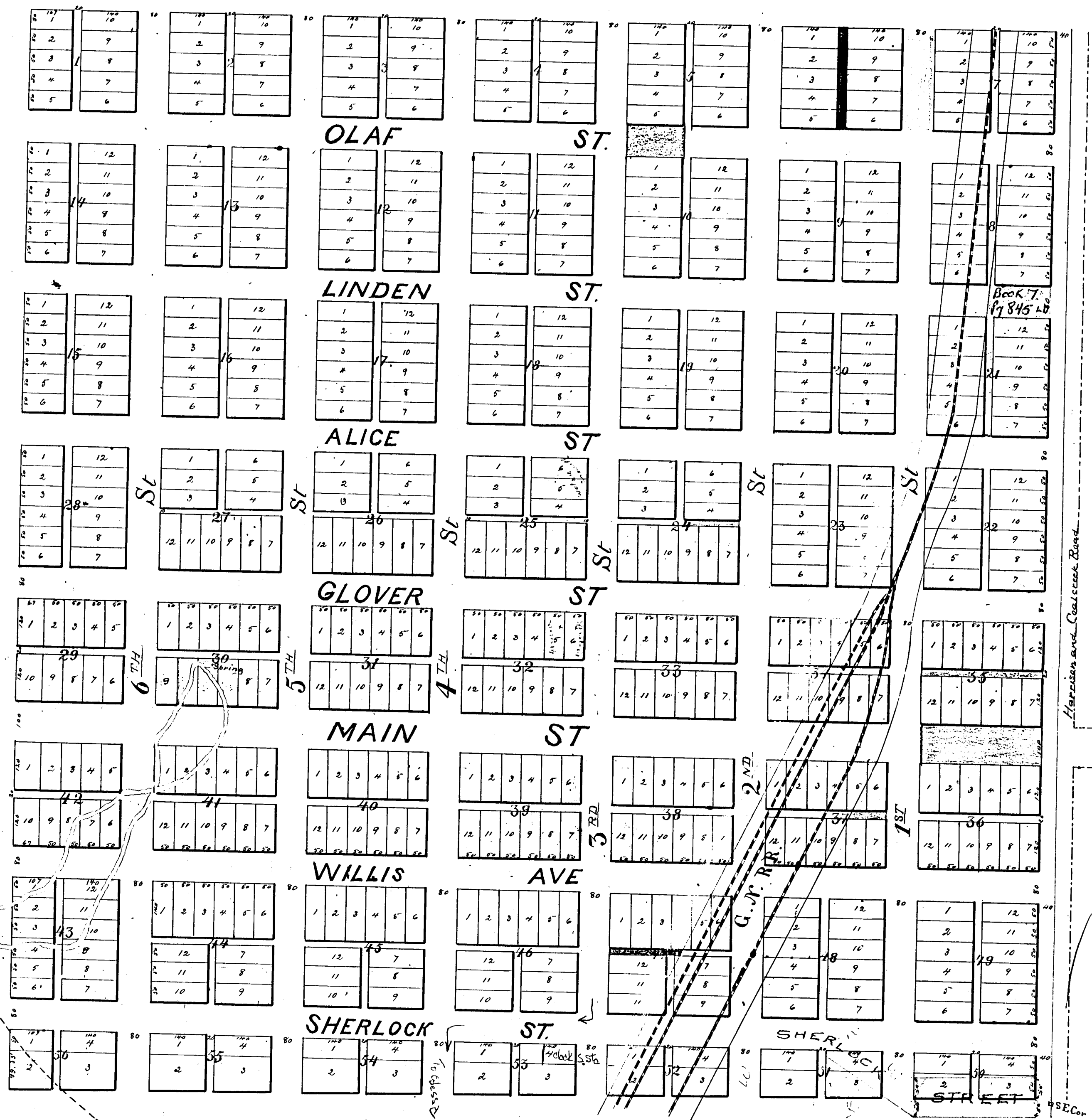


PLAT OF HARRINGTON

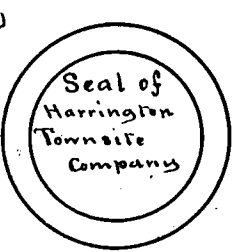
Dedication to corrected Plat of Harrington

Know all men by these presents, that the Harrington Townsite Company, a corporation has platted as a Townsite called Harrington the following described tract of Land to wit; The South East quarter (SE 1/4) of Section fifteen (15) in Township twenty three (23) North of Range thirty six (36) E.W.M. Situate in Lincoln County Washington, and have subdivided said tract of Land into Lots and Blocks Streets and Alleys, of the numbers and sizes and dimensions as shown on the annexed plat, and do hereby dedicate the Streets and Alleys shown thereon as public highways, it being the intent hereof to confirm the plat and dedication of said tract of Land heretofore made and filed in the office of the Auditor of said Lincoln County and to show the correct numbers of all Lots and Blocks as so platted, in as much as erroneous numbers were placed on certain Lots on said original plats after the same had been lodged for Record in said Auditors office.

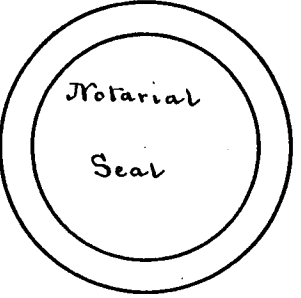
