presentation on Bioeconomy Development Opportunity Zone and performing an investment grade rating to attract new bio-based manufacturing plants to areas where they are most likely to succeed and create jobs. They discussed the RBDG Grant, which is no cost to the county or EDC, it will all be funded by the grant. They will need 5 letters of support, and a Board Resolution,

with Ecostrat managing all portions of the grant.

MOTION By unanimous vote, the Commissioners authorized the moving forward of an application for the

grant to perform the BDOZ through the RBDG Grant.
